FALLS - RISK REDUCTION AND MANAGEMENT OF INPATIENT FALLS

POLICY STATEMENT

It is Bay of Plenty District Health Board's (BOPDHB) policy that there will be systems and processes in place to promote independence, safe mobilisation and to minimise the risk of harm from falls for all patients in BOPDHB facilities.

PURPOSE

All inpatients are at high risk of falling, the purpose of the falls prevention and management program is to:

- Identify and initiate appropriate individual assessment, interventions and strategies directed to minimise the risk of harm from falling.
- Identify and provide learning opportunities to patients, families and staff.
- Identify and monitor, analyse and evaluate all patient falls and near misses.

EXCLUSIONS

Non-inpatient units, non-inpatient falls will be reported through the Incident Management system.
